- III. Tax-Exempt 501 (c) (3) Bond Request

A. Ballad Health (formerly Wellmont Health System and Mountain Sates Health Alliance) - Ms. Sisson-Vaughan presented a \$350 million bond resolution authorizing the refinance of debt for Virginia facilities. Mr. TW Bruno, bond counsel, explained the financing and the expected impact of the merger of the two previously independent healthcare systems serving Southwest VA and Northwestern TN. On a motion by Mr. Holeman, seconded by Mr. Smith, the Board of Directors unanimously approved the resolution as presented. Voting aye: Acting Chairman Joyce, Mr. Holeman, Mr. Smith, Dr. Johnson, Mr. Hoang, Ms. Aylor, and Ms. Wiley. Voting no: None.

- Ms. Wiley updated the Board on the legislation affecting the agency during the recent GA session. Due to changes in HB1568, the agency will remain whole and the two grant programs will remain at DSBSD.
